Symrise's mandatory offer to the shareholders in Swedencare – Symrise announces offer document

On 25 May 2023, it was announced that Symrise AG (“**Symrise**”) had acquired an additional 2,300 shares in Swedencare AB (publ) (“**Swedencare**”) (the “**Acquisition**”) and that Symrise thereafter owned in total 47,619,618 shares in Swedencare, corresponding to 30 percent of the number of shares and votes in Swedencare. The threshold for mandatory public offers had thus been exceeded and Symrise declared its intention to submit a mandatory public offer for the remaining shares in Swedencare (the “**Shares**”) within four weeks, in accordance with the takeover rules for certain trading platforms issued by the Swedish Stock Market Self-Regulation Committee. On 5 June 2023, Symrise announced a mandatory public offer to the shareholders in Swedencare (the “**Offer**”). Today, Symrise published an offer document.

Offer document etc.

An offer document, containing such information that must be included in offer documents in accordance with the takeover rules, has today been published (the “**Offer Document**”). The Offer Document and acceptance forms are held available on Symrise's website (www.symrise.com/swedencare) and will also be held available on Skandinaviska Enskilda Banken AB's website (www.sebgroup.com/prospectuses). A pre-printed acceptance form will be sent to shareholders in Swedencare whose shares are directly registered with Euroclear Sweden AB.

The acceptance period commences on 21 June 2023 and expires on 26 July 2023. Settlement is expected to occur on 3 August 2023. Symrise reserves the right to extend the acceptance period for the Offer, as well as the right to postpone the settlement date.

Shareholders in the United States are advised that the shares in Swedencare are not listed on a U.S. securities exchange and that Swedencare is not subject to the periodic reporting requirements of the U.S. Securities Exchange Act of 1934, as amended (the “**Exchange Act**”), and is not required to, and does not, file any reports with the U.S. Securities and Exchange Commission (the “**SEC**”) thereunder.

The Offer will be made for the issued and outstanding shares in Swedencare (not already owned or controlled by Symrise), which is domiciled in Sweden, and is subject to Swedish disclosure and procedural requirements. The Offer will be made in the United States pursuant to Section 14(e) and Regulation 14E under the Exchange Act, and otherwise in accordance with the disclosure and procedural requirements of Swedish law, including with respect to the Offer timetable, settlement procedures, withdrawal, waiver of conditions and timing of payments, which are different from those of the United States. The Offer is made to Swedencare’s shareholders resident in the United States on the same terms and conditions as those made to all other shareholders of Swedencare to whom an offer is made. Any information documents, including this press release, are being disseminated to U.S. shareholders on a basis comparable to the method that such documents are provided to Swedencare’s other shareholders.

To the extent permissible under applicable law or regulations, Symrise and its affiliates or its brokers and its brokers’ affiliates (acting as agents for Symrise or its affiliates, as applicable) may from time to time after the date of this press release and during the pendency of the Offer, and other than pursuant to the Offer, directly or indirectly, purchase or arrange to purchase, the shares in Swedencare or any securities that are convertible into, exchangeable for or exercisable for such shares. These purchases may occur either in the open market at prevailing prices or in private transactions at negotiated prices. Swedencare’s shareholders may not be able to sue Symrise or Swedencare or their respective officers or directors in a non-U.S. court for violations of the U.S. federal securities laws. It may be difficult to compel Symrise and Swedencare and their respective affiliates to subject themselves to a U.S. court’s judgment.
